





BACKGROUND: The need for parking school buses in the County was identified and discussed at the Student Transportation Ad Hoc Committee meeting on July 18, 2016 and at the September 15, 2016 meeting staff outlined the near-term parking needs and provided a list of all of the sites that have been considered or are currently under consideration.

DISCUSSION: The current parking status and an update on the status of several sites currently under consideration are presented below.

Long Term

Marin Transit applied to the Transportation Authority of Marin for One Bay Area Grant (OBAG) Cycle 2 funds from the Safe Routes to Schools or local funding source in the amount of \$864,000. This would be matched with \$112,000 in Marin Transit Measure A funds, for a total project amount of \$976,000. These funds would be used to plan for and lease or buy a site for school bus parking. TAM is expected to recommend awarding the Safe Routes to Schools portion of OBAG 2 funding later this year.

RECOMMENDATION:

Although we have a parking solution for the FY17/18 school year, there is still urgency to find a site for a 3-5 year term to take the District through identification of a long term solution to funding school bus services in

Marin County, and to ensure the best pricing when the current school bus contracts come up for renewal in a year. As discussed with the Ad Hoc Committee, the lack of local parking for school buses impacts competition for service contracts, increases contract costs, and reduces service reliability.

Staff recommends that we continue efforts to secure a 3-5 year lease for school bus parking and return to the Ad Hoc Committee with a preferred site and funding plan.

SUBJECT: Comparison of Cooperative Yellow Bus Programs in the Bay Area

Dear Ad Hoc Committee Members:

BACKGROUND: As yellow bus service in Marin County continues to expand and Marin Transit plays a larger role in managing the operations, the District is looking to other established programs in the area to guide the future growth of our own home to school initiative. The Coordinated Countywide School Transportation Study completed in December 2015, described the need to research and identify the most appropriate organizational structure for an expanded yellow bus program. The comparison presented in this letter is an initial step in evaluating a future organization structure.

Marin Transit has organically grown its role in providing and managing home to school transportation in Marin County. The District is in a unique position as a public transit agency in that it provides supplemental (tripper) services to complement its regular fixed route services and it also plays a strong role in planning and managing yellow bus operations for three other school districts in the County. If continued expansion of yellow bus occurs in the County, it is likely that a new or alternative organizational arrangement will be needed to sustain and support this growth.

DISCUSSION: Marin Transit reviewed four yellow bus programs in the Bay Area: TRAFFIX (San Ramon Valley), Lamorinda schools, West County Transportation Agency (Sonoma County), and Marin Pupil Transportation Agency (MPTA). All programs reviewed are structured as Joint Powers Authorities (JPAs) which encourage collaboration and cooperation across different stakeholders. The different types of stakeholders can be seen in the makeup of the Boards for each program. Both Lamorinda and TRAFFIX were established as traffic relief programs and are largely funded through the Measure J ½ cent sales tax that was approved by the voters in Contra Costa County in 2004. On the Boards of the respective JPAs are representatives from both the School Districts and the Cities/Counties from which they receive their funding. The West County and Marin Pupil JPA's in contrast are funded

steve kinsey director supervisor district 4 exclusively through contributions from the participating schools and their Boards are subsequently comprised only of members of the participating School Districts.

West County is exceptional and unique as it is the only program that owns parking, maintenance facilities, and buses as well as directly employs and trains drivers. This gives them a greater level of control; however, the fixed overhead costs necessary to operate the program are also much higher than the other programs studied. The three other programs reviewed contract out all service to a third-party contractor, First Student.

Additional details on the four programs reviewed are provided in the attached matrix.

CONCLUSION: To grow the yellow bus program in Marin County and further reduce traffic congestion, the Marin Transit Board will need to consider organizational options for the future structure of the yellow bus program management with key stakeholders including schools, MCOE, cities, the County, and TAM. In discussing the organizational options, the Marin Transit Board will need provide direction on Marin Transit's role in the future of these services. In addition, to develop a comprehensive county-wide sales tax measure a detailed explanation of how the funds will be managed and by what governing body will be critical to the success of the measure with the voters.
