 - Roadway construction projects
 - School bell changes
- No significant change in service levels (revenue hours)





Marin Sonoma Transit Coordination


- GGBHTD

- Two counties have a long history of coordination
- Changes in travel patterns, funding, and current planning efforts prompted rethinking service coordination
- Transit agencies, TAM, SCTA and MTC convened to discuss GGBHTDs Strategic Planning Initiative
- Agencies agreed to develop a comprehensive service plan focused on the 101 corridor
- Planning kicks off in January and completes in 12-18 months



Regional Network Management Council

- FY 24/25 Workplan actions:
 - Result in direct benefits to riders
 - Demonstrate positive change to policymakers and riders ahead of a potential 2026 regional measure
 - Guided by the Transformation Action Plan


